

**PUBLIC PATH STOPPING UP AND DEFINITIVE MAP AND STATEMENT  
MODIFICATION ORDER  
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257  
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53A(2)**

**THE COUNCIL OF THE BOROUGH OF STOCKTON-ON-TEES  
PUBLIC FOOTPATH NO.4 – INGLEBY BARWICK (IN PARTS)  
PUBLIC FOOTPATH STOPPING UP ORDER 2021**

This Order is made by the Council of the Borough of Stockton-on-Tees “the Authority” under section 257 of the Town and Country Planning Act 1990 (“the 1990 Act”) because it is satisfied that it is necessary to stop up the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: the erection of 65 residential dwellings on land off Roundhill Avenue, Ingleby Barwick, Stockton-on-Tees under Application Reference 18/1459/REM.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Borough of Stockton-on-Tees definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

**BY THIS ORDER:**

1. The footpath over the land shown by a bold orange continuous line on the map attached to this Order and described in Part 1 of the Schedule to this Order (“the Schedule”) shall be stopped up as provided below.
2. The stopping up of the footpath shall have effect upon the estate roads being adopted and upon the occurrence of that stopping up the Borough of Stockton-on-Tees definitive map shall be modified by deleting from it the path or way referred to in paragraph 1 of this order and the definitive statement shall be modified as described in Part 2 of the Schedule.

**SCHEDULE**

**Part 1**

**Description of site of existing Path or Way**

The footpath over land off Roundhill Avenue, Ingleby Barwick, which is approximately 350m in length as indicated by a solid orange line between points ‘G’ to ‘H’ to ‘I’ on plan no. H117-285.

**Part 2**

**Modification of Definitive Statement of Public Right of Way**

The existing description of Public Footpath No 4 - Ingleby Barwick shall be replaced with the following wording

**Public Footpath No 4 – Ingleby Barwick** – from the rear of 1 Crosswell Park and in a north westerly direction across Crosswell Park, Blenheim Court, Nevern Crescent and Hasguard Way to join new housing estate footpath.
