

**STOCKTON-ON-TEES BOROUGH COUNCIL

TEMPORARY ROAD CLOSURE ORDER 2022**

**ROAD TRAFFIC REGULATION ACT 1984**

WHEREAS the Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") is satisfied that access along the said section of road specified in the Schedule hereto shall be prohibited because works are being or are proposed to be carried out on or near the road.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and all other enabling powers hereby make the following Order:-

1. The Order shall come into operation on the 23<sup>rd</sup> September 2022 and may be cited as The Stockton-on-Tees Borough Council, Carriageway Resurfacing Programme 2022/2023 – Additional Areas, Temporary Road Closure Order 2022.
2. No vehicle shall proceed along the lengths of the road specified in the Schedule hereto at any time when traffic management signs have been erected to notify highway users of the closure, the works are expected to be carried out over an 18 month period commencing on approximately 23<sup>rd</sup> September 2022. A letter drop will be carried out at each location giving the affected residents prior notification of when works are to commence on site.
3. The Order may continue in force for a maximum period of 18 months.

### Temporary Road Closure

LOCATION	EXTENT
Tedder Avenue, Thornaby (HNM/660-11)	Between its junctions with Hampden Way and Stirling Way
Letch Lane, Stockton (HNM/660-12)	From a point approximately 400 metres west of its junction with Harrowgate Lane in a westerly direction for approximately 290 metres
Low Grange Avenue (HNM/660-13)	Between its junctions Marsh House Avenue and Neasham Avenue
