

**THE BOROUGH OF STOCKTON-ON-TEES
(STOCKTON TOWN CENTRE OFF-STREET PARKING PLACES) ORDER 2014
(AMENDMENT) ORDER 2023**

The Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 33, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the 27th day of July 2023 and may be cited as The Borough of Stockton-on-Tees, (Stockton Town Centre Off-Street Parking Places) Order 2014 (Amendment) Order 2023.
2. The Borough of Stockton-on-Tees (Stockton Town Centre Off-Street Parking Places) Order 2014 ("the 2014 Order"), The Borough of Stockton-on-Tees (Stockton Town Centre Off-Street Parking Places) Order 2014 (Amendment) Order 2016 ("the 2016 Order") and The Borough of Stockton-on-Tees (Stockton Town Centre Off-Street Parking Places) Order 2014 (Amendment) Order 2019 ("the 2019 Order") shall be amended as follows but shall otherwise remain in full force and effect.
3. The words specified in Schedule 1 hereto are deleted from Schedule 2 of the 2016 Order.
4. Sub paragraph (14) of Article 6 of the 2016 Order is revoked and replaced with the following wording: -

(14) No person shall cause an Electric Vehicle to wait in an Electric Vehicle Charging Bay for longer than two hours.
5. Article 6 of the 2016 Order (which amends Article 4 in the 2014 Order) **Use of Off Street Parking Places** after sub-paragraph (16) shall read: -

(17) Charges for electricity will be market value to ensure subsidy control compliance.

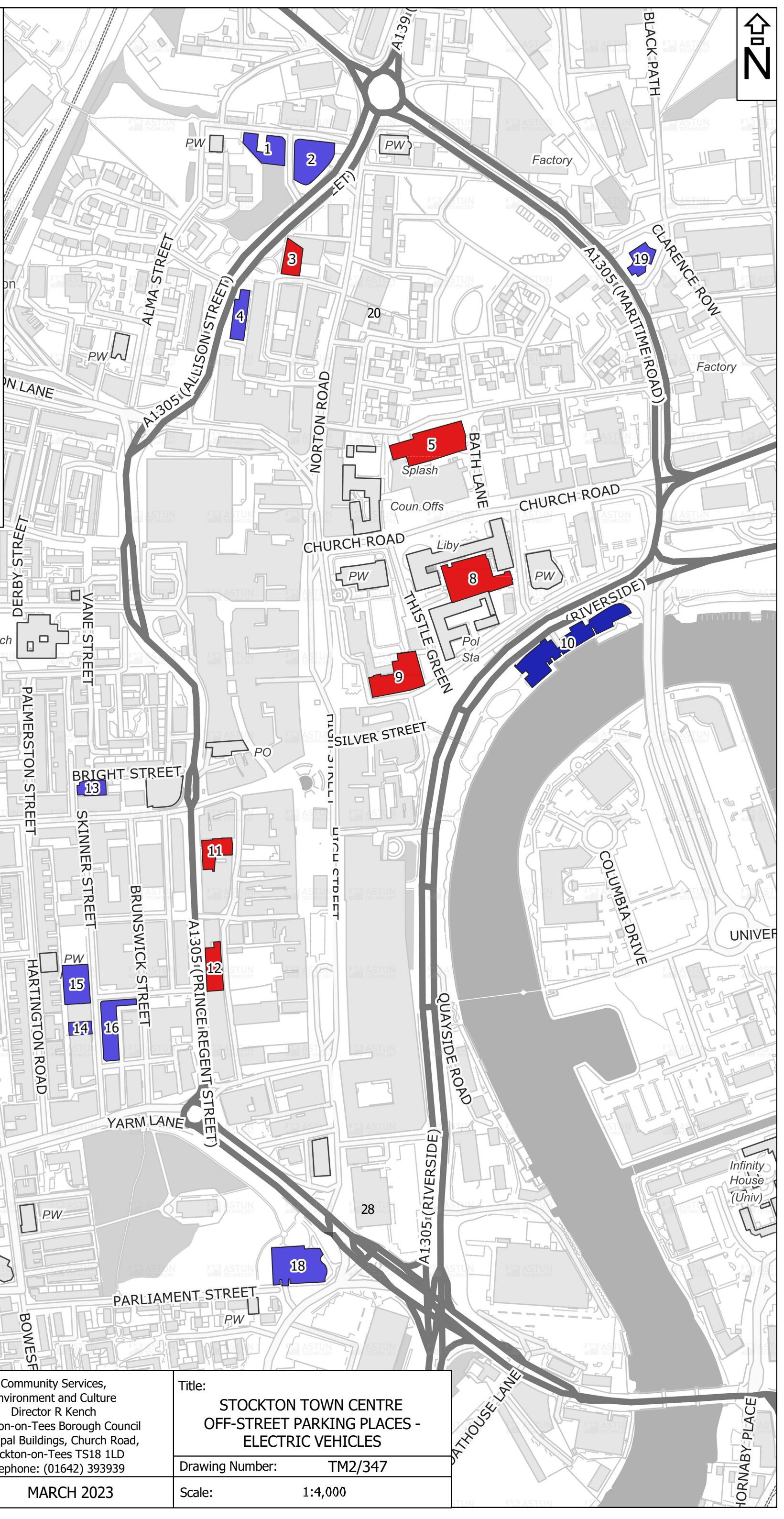
