

**THE BOROUGH OF STOCKTON-ON-TEES
BELASIS AVENUE, COWPEN LANE & CENTRAL AVENUE, BILLINGHAM
TRAFFIC REGULATION ORDER 2021 (AMENDMENT NO 1) ORDER 2023**

The Council of the Borough of Stockton-on-Tees (“the Council”) in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on the day of 2023 and may be cited as The Borough of Stockton-on-Tees, Belasis Avenue, Cowpen Lane & Central Avenue, Billingham Traffic Regulation Order 2021 (Amendment No 1) Order 2023.
2. In this Order the definitions in the 2021 Order shall apply to this Order unless otherwise stated
3. The Borough of Stockton-on-Tees, Belasis Avenue, Cowpen Lane & Central Avenue, Billingham Traffic Regulation Order 2021 (“the 2021 Order”) shall be amended as follows but shall otherwise remain in full force and effect.
 - 3.1 The following words specified in Schedule 1 of the 2021 Order in so far as they relate to Central Avenue, Billingham (North Side) are to be deleted

“From a point approximately 98 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 99 metres”

and replaced with the following

“From a point approximately 81 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 116 metres”.
 - 3.2 The following words specified in Schedule 2 of the 2021 Order in so far as they relate to Central Avenue, Billingham (North Side) are to be deleted

“From a point approximately 98 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 99 metres”

and replaced with the following

“From a point approximately 81 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 116 metres”.
 - 3.3 The following words specified in Schedule 3 of the 2021 Order in so far as they relate to Central Avenue, Billingham (North Side) are to be deleted

“From a point approximately 32 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 66 metres”

and replaced with the following

“From a point approximately 32 metres east of its junction with Cowpen Lane in an easterly direction for a distance of approximately 49 metres”.

- Save as provided in Article 9(2) of the 2021 Order no person shall, except upon the direction or with the permission of a Civil Enforcement Officer or a police officer in uniform, cause or permit any vehicle to carry out the U Turn manoeuvres specified in the second column of the Schedule to this Order on the length of the road specified in the first column of the Schedule of this Order

Length of Road/Location of Prohibited U Turns	Prohibited U Turn Manoeuvre
On Central Avenue, Billingham at the signalised junction approximately 81 metres east of its junction with Cowpen Lane	Vehicles travelling east along Central Avenue shall not carry out a U Turn to travel west along Central Avenue Vehicles travelling west along Central Avenue shall not carry out a U Turn to travel east along Central Avenue Vehicles exiting the property to the north of Central Avenue at the signalised junction onto Central Avenue shall not carry out a U Turn to enter the property again
