

**STOCKTON-ON-TEES BOROUGH COUNCIL
A1305 RIVERSIDE, STOCKTON
TEMPORARY TRAFFIC REGULATION ORDER 2024**

ROAD TRAFFIC REGULATION ACT 1984

WHEREAS the Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") is satisfied that access along the said section of road specified in the Schedule hereto shall be prohibited because works are being or are proposed to be carried out on or near the road.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and all other enabling powers hereby make the following Order: -

1. The Order shall come into operation on the 15th January 2024 and may be cited as the Stockton-on-Tees Borough Council, A1305 Riverside, Stockton, Temporary Traffic Regulation Order 2024.
2. No vehicle shall proceed along the lengths of roads specified in Schedule 1 hereto at any time when traffic management signs have been erected to notify highway users of the closure.
3. No vehicle shall proceed along the length of road specified in Schedule 2 at a speed exceeding 20mph when traffic management signs have been erected to notify highway users of the temporary speed limit.
4. No vehicle travelling southbound on the A1305 Riverside, Stockton shall turn right onto Tower Street when traffic management signs have been erected to notify highway users of the right turn prohibition or the manoeuvre is prevented by traffic barriers or signs.
5. No vehicle shall stop, wait, load, or unload along the length of road specified in Schedule 4 at any time when traffic management signs may have been erected to notify highway users of the clearway.
6. No vehicle shall carry out a U-Turn at the locations specified in Schedule 5 when traffic management signs have been erected to notify highway users of the restriction or barriers or traffic signs are present which prevent the manoeuvre.
7. No vehicle shall proceed along the length of road specified in Schedule 6 when traffic management signs have been erected to notify highway users of the restriction. A one-way system, Westbound only, shall be in operation.
8. No vehicle exceeding 2 metres in width shall proceed along the lengths of road specified in schedule 7 when traffic management signs have been erected to notify highway users of the temporary width restriction.
9. Article 3 shall not apply to the following:
 - i) an emergency services vehicle responding to an emergency or;

- ii) a vehicle used for naval, military or air force purposes if it is being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when: -
 - (a) the person driving the vehicle is a member of the Special Forces; and
 - (b) the vehicle is being driven -
 - (c) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (d) for the purpose of training a person in driving vehicles at high speeds.

10. This Order may continue in force for a maximum period of eighteen months.

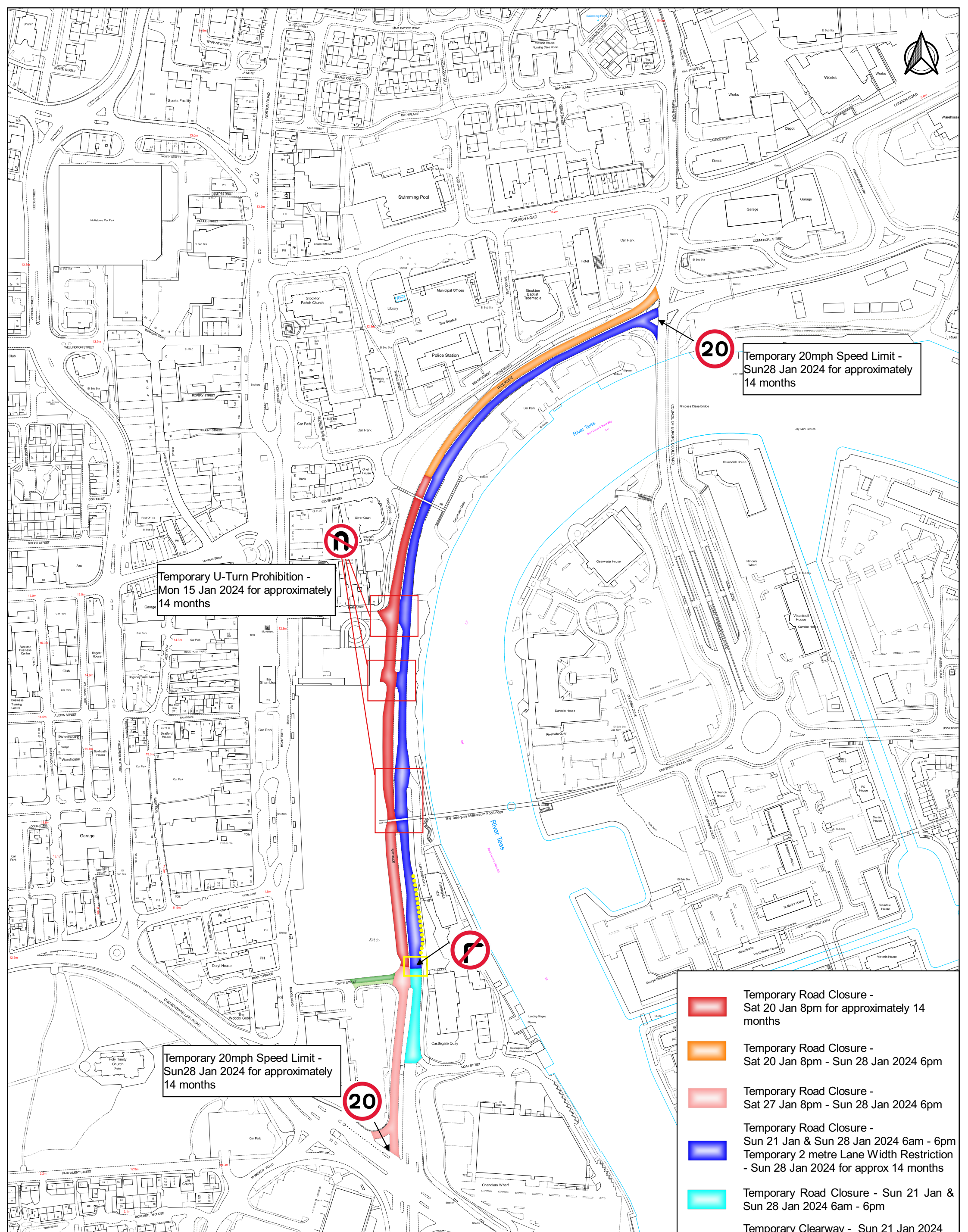
