#### THE BOROUGH OF STOCKTON-ON-TEES (CHURCH ROAD AREA, STOCKTON-ON-TEES) (PROHIBITION OF WAITING) ORDER 1997 AMENDMENT (NO.4) ORDER 2024

The Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35 & Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

- 1. This Order shall come into operation on 2024 and may be cited as The Borough of Stocktonon-Tees (Church Road Area, Stockton-on-Tees) (Prohibition of Waiting) Order 1997 Amendment (No.4) Order 2024.
- 2. Schedule 2 of The Borough of Stockton-on-Tees (Church Road Area, Stockton-on-Tees) (Prohibition of Waiting) Order 1997 (1997 Order) is hereby varied by the deletion of the wording in the second column of Schedule 1 of this Order and the insertion of the wording in the third column of Schedule 1 of this Order.
- 3. Schedule 2 of the 1997 Order is further varied by the insertion of the wording at Schedule 2 of this Order but shall otherwise remain in full force and effect.
- 5. No person shall, except upon the direction, or with the permission, of a Civil Enforcement Officer or a police constable in uniform, cause or permit a vehicle to stop, wait, load, or unload when proceeding along the length of the road specified in Schedule 2 of this Order.


