3	Board Memorandum of Understanding (MOU) Initial MOU has been agreed but a refreshed version is required to reflect the current delivery phase and role of the Board.		

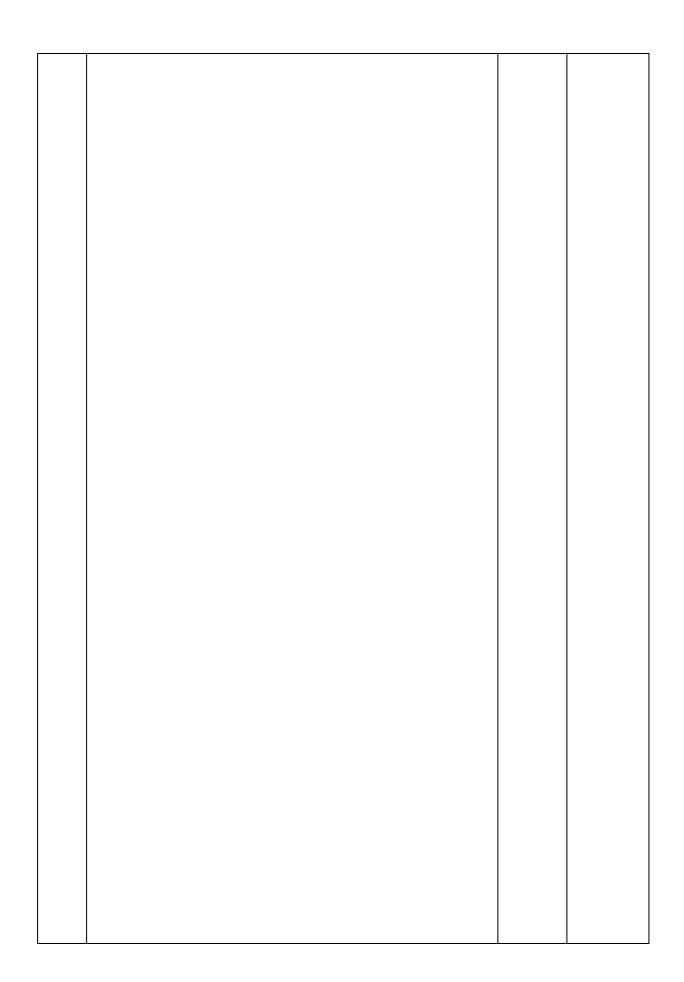

Matt Vickers MP asked whether the new car park would include any landscaping – lan responded that the aspiration is to soften the site with trees and shrubs.	
Matt Vickers MP then asked for further detail on the T Level scheme funding and what this will look like operationally – Phil and Lesley Graham responded that the budget is £2.5m which includes Government funding with the majority committed to the new building to create a range of new facilities in a modern training environment. Lesley then offered to facilitate a visit for Matt Vickers MP to view the facility.	
Chair asked about connectivity to the site.	
Jonathan Kibble responded that Teesdale is currently served by public transport along Harvard Avenue and referenced the recent announcement of investment in a transport hub at Teesside Park. The site is well connected with pedestrian access via Infinity Bridge.	
Cllr Godwin commented that it's great to see a long-term vision for Teesdale as a whole and how the site will be repurposed. Provisions such as this are paramount to the development of the area.	
North Thornaby (Jane Edmends)	
<u>Community Park</u> – Refurbishment works to hall and play equipment complete with Little Sprouts now running a café.	
<u>Safer Streets</u> – Work carried out in 524 properties to date with a total of just over 6,500 interventions and a number of jobs passed to partner agencies such as CFYA and Cleveland Fire Brigade. An initial area was prioritised but the number of people interested is now slowing down. Will look to widen the project area and bring back to the board for agreement.	
<u>Empty Properties</u> - Priority properties identified and active offers going in to bring back in to use. One problematic empty home not proving successful but now able to pursue alternative legal options and 2 further properties will be going back to auction.	
Energy Efficiencies – Total cost of measures installed to date is $\pounds184,284.84$ with a total of 69 measures installed.	
Cllr Mick Moore asked what the uptake in Solar Panels is. Jane responded that 25 properties have received so far.	
Cllr Nigel Cooke commented that progress is encouraging. There are wider issues across North Thornaby and whilst that sits outside the remit of this board, the Local Authority has a serious ambition to try and tackle.	
<b>Cycleways</b> (Jonathan Kibble)	



	Jonathan provided an overview of the proposals which aims to fill in the gaps in the existing infrastructure and provide as much connectivity into the town centre.	
	Engagement sessions took place in September 2023 and included a high level overview of the proposals. A banner and forms were left in Thornaby Pavillion throughout September. 22 responses were received with 55% being of a positive of general nature.	
	Sweco have been appointed to undertake detailed design over the coming months with an intention to go out to tender and start on site late summer. Further consultation to take place with those residents who will be directly affected.	
	Completion of detailed design should be in line with next meeting date and will look to invite Sweco along to talk through design.	
	Cllr Ray Godwin queried how you would get from Lanehouse Road/South Thornaby to North Thornaby and what opportunities there are for getting children involved in cycling. Jonathan responded that TVCA are investing in other networks as well as working with schools through a Public Health England funded post, to get children involved. Cllr Ray Godwin added that the quality of the scheme is promising and good that it's passing by both secondary schools.
