

**THE BOROUGH OF STOCKTON-ON-TEES
ELTON INTERCHANGE (VARIOUS SPEED LIMITS) ORDER 2023
AMENDMENT ORDER 2024**

The Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1. This Order shall come into operation on **XX** 2024 and may be cited as The Borough of Stockton-on-Tees, Elton Interchange (Various Speed Limits) Order 2023, Amendment Order 2024.
2. No vehicle shall proceed along the lengths of road specified in Schedule 1 at a speed exceeding 50 mph.
3. The Borough of Stockton-on-Tees, Elton Interchange (Various Speed Limits) Order 2023 is hereby varied by the replacement of the wording in Schedule 1 of that Order with the wording in Schedule 1 of this Order.
4. The Borough of Stockton-on-Tees, Elton Interchange (Various Speed Limits) Order 2023 is hereby varied by the revocation of Article 5 of that Order.
5. Nothing in Article 2 of this Order shall apply to an emergency services vehicle responding to an emergency.
6. Article 2 shall not apply to a vehicle used for naval, military or air force purposes if it is being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when -
 - (a) the person driving the vehicle is a member of the special forces; and
 - (b) the vehicle is being driven -
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.

SCHEDULE 1 – 50mph speed limit

Durham Lane, Eaglescliffe, Stockton-on-Tees	From a point approximately 370 metres south of its junction with the A66/Elton Interchange in a southerly direction to a point approximately 182 metres north of its junction with Cleasby Way.
